



**GUIDELINES FOR CCC PROCESS FOR FAST TRACK PROVISIONAL (Eligible overseas applicants with a CCC ie. ASHA-CCC-A, ASA-CCP, CASLPA—Aud (C)) AND REJOINING MEMBERS.**

- 1) Applicants must complete 2 secondments before being eligible to apply for their examination:
  - Paediatric Hearing Aid Experience – please see Section J for details on this.
  - ABR Experience — please see Section I for details on this.
  
- 2) An applicant must complete a satisfactory Exam (which encompasses one and a half day's direct observation PLUS 4 chart reviews) and includes an Oral Examination.

Clinical Observation should include:

- A minimum of one pre-school paediatric assessment and two infant paediatric assessments (one as distractor and one as presenter)
- One adult diagnostic and rehabilitation needs assessment case
- One adult hearing aid fitting

Chart Reviews should include:

- 4 x chart reviews (randomly chosen by the examiner). These charts have to be genuine referrals in an area that involves rehabilitation, preferably in the area of your expertise (e.g. Vestibular, ABR, tinnitus, APD or hearing aid management).
- One paediatric ABR and one paediatric hearing aid case (supplied by the examiner).

Oral Examination:

- Based primarily on New Zealand issues
- 2) Candidates must contact their CCC Co-ordinator to arrange their examination.
  
  - 3) There is a cost of \$1500 (incl GST) associated with this examination.
  
  - 4) In the event that the candidate does not meet all of the requirements to join the society, the candidate is entitled to resit the exam in the areas where competence was not shown. If the candidate fails a second time the membership and supervision subcommittee will consider either another resit or will ask the candidate to join the society as a provisional member rather than a fast track candidate. As a provisional member they are required to complete the full minimum eleven month CCC process.

**At the completion of the exam:**

The examiner will write an examination report. The exam result cannot be given to candidates on the day of the exam as written reports and results summary sheets are still to be marked.

The examination report will be sent to the Membership and Supervision Subcommittee. If the outcome is satisfactory, your name will be circulated in the next Society newsletter as having completed the requirements necessary for full membership. If no objections are received within 28 days you will be deemed a full member and can then use the letters MNZAS after your name. You will then automatically receive your CCC and Continuing Education Certificate valid for the remainder of the year.
